### **INFORMAZIONI SULL'APOSTILLE\***

#### **Cos'è l'Apostille?**

L'Apostille è un certificato rilasciato da un'autorità autorizzata di un Paese che ha aderito alla Convenzione dell'Aia del 5 ottobre 1961.

Un'Apostille autentica e riconosce i sigilli e le firme riportati sui documenti pubblici, per esempio atti di stato civile, notarili, ordini del tribunale, e qualsiasi altro documento rilasciato da un'autorità pubblica straniera, affinché i documenti possano essere riconosciuti nei paesi membri della Convenzione dell'Aia.

#### **Quali uffici rilasciano l'Apostille?**

Negli Stati Uniti ci sono varie Autorità competenti per il rilascio dell'Apostille, le quali dipendono dall'origine del documento in questione:

- I documenti federali (per esempio un certificato penale dell'FBI) sono autenticati dal *US Department of State Authentications Office*.
- I documenti statali (per esempio atti di stato civile, documenti autenticati da un notaio pubblico, un certificato penale statale, ecc) sono autenticati dal *Secretary of State* dello stato dove l'atto è stato rilasciato.

#### **Come e dove si richiede l'Apostille? Quali documenti sono richiesti? Quanto costa?**

Consultare il sito web del Segretario di Stato dello stato dove il documento è stato rilasciato, facendo riferimento alla sezione "*Authentications*" oppure "*Apostille*."
