**EXPLORATIVE INVESTIGATION AIMED AT THE ACQUISITION OF MANIFESTATIONS OF INTEREST FOR THE PARTICIPATION IN THE PROCEDURE FOR THE AWARDED PROCEDURE UNDER ARTICLE 10 paragraph 1 OF THE Decree of the Ministry of Foreign Affairs No. 192/2017 OF THE WORKS FOR THE RENOVATION OF THE ROOF AND DAMAGED ENVIRONMENTS OF THE CONSULATE GENERAL OF ITALY IN SAN FRANCISCO.**

The Consulate General of Italy in San Francisco is promoting an exploratory survey aimed at parties potentially interested in participating in the bidding process for the renovation of the Consulate's damaged roof and rooms.

### Target audience

The survey is aimed at companies possessing the requirements, experience, professionalism and technical and economic capacity to enter into the contract.

### Purpose

The survey is intended solely to receive expressions of interest from parties potentially interested in participating in the procedures for the selection of the economic operator and thus to receive an invitation to bid for the work in question, without any compromise binding this Consulate General. Expressions of interest received with the required data will not be binding in any way. Participating parties will not accrue any advantageous position in relation to the Administration's future choices.

### Guarantees accompanying the expression of interest

The expression of interest, must be received indicating the following guarantees: - Approvals issued by the competent local U.S. Authorities to operate in the field; - Professional technical capabilities for the work to be performed and previous experience in the field in the U.S.; - Soundness of the company's financial arrangements by demonstrating sound economic and financial capacity.

### Method of submission of the expression of interest
